**RESOLUTION AMENDING RESOLUTION NO. 18-360 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OF BAGO FOR THE ESTABLISHMENT AND OPERATION OF YOUTH CENTERS AT RT MALINGIN NATIONAL HIGH SCHOOL, RT DULAO NATIONAL HIGH SCHOOL, RT SAGASA NATIONAL HIGH SCHOOL AND MA-AO CENTRAL NATIONAL HIGH SCHOOL IN FURTHERANCE OF THE ADOLESCENT HEALTH AND DEVELOPMENT PROGRAM OF THE CITY GOVERNMENT".**
