RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY OF BAGO AND THE DIFFERENT BARANGAYS OF THE CITY WHEREIN THE CITY SHALL PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF P80,000.00 PER BARANGAY FOR THE TOURISM PROMOTION DURING THE 53RD CHARTER DAY CELEBRATION OF THE CITY.
