WHEREAS, in a letter dated January 22, 2019, PSupt. Jimmy M. Laguyo of the Regional Training Center, Philippine Public Safety College, requested the use of MYTSC facilities and NOFA building for their Officers Orientation Course (OOC) for the period March 1, 2019 to November 30, 2019;

WHEREAS, in a Committee Hearing conducted by the Committee on Government Assets, it was found out that the facilities will be subjected to renovation and repair by the City Engineering Office and the Committee recommended to the plenary that the request may not be favorably granted as a consequence thereof; and


