RESOLUTION NO. 19-126

RESOLUTION APPROVING THE DONATION AND AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE WITH PHILIPPINE NATIONAL POLICE, NEGROS OCCIDENTAL POLICE PROVINCIAL OFFICE TO DETERMINE THE AREA TO BE DONATED FOR THE CONSTRUCTION OF THE STANDARDIZED POLICE STATION IN THE CITY OF BAGO.

WHEREAS, the August body is in receipt of a communication from the Honorable City Mayor endorsing the request of PSSupt. Romeo A. Baleros, Officer-In-Charge, Negros Occidental Police Provincial Office, Philippine National Police, Bacolod City, for a lot donation from the local government for the construction of the Philippine National Police (PNP) standard building;

WHEREAS, the said request was referred to the Joint Committees on Government Assets and Peace and Order, Fire and Public Safety which, after the conduct of a Committee Hearing recommended to the plenary that the request be favorably acted upon; and

WHEREAS, after thorough deliberation it is the consensus of this August body to favorably adopt the recommendation.
