RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF UNDERSTANDING TO BE EXECUTED BY AND BETWEEN THE CULTURAL CENTER OF THE PHILIPPINES AND THE CITY OF BAGO FOR A PARTNERSHIP IN THE CONCEPTUALIZATION OF THE KAISA SA SINING (KSS) IN THE ESTABLISHMENT OF REGIONAL-SATELLITE PARTNERS IN THE REGION, TO BROADEN PUBLIC PARTICIPATION IN THE ARTS, PROMOTE AND SHOWCASE ARTISTIC EXCELLENCE AND FACILITATE A DYNAMIC COLLABORATION BETWEEN AND AMONG THE REGIONAL ART CENTERS.
