RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT WESTERN VISAYAS AND THE BAGO CITY HOSPITAL FOR THE DONATION OF VARIOUS MEDICAL EQUIPMENT AMOUNTING TO ONE MILLION TWO HUNDRED FOUR THOUSAND TWO HUNDRED SIXTY NINE PESOS AND EIGHTY CENTAVOS (PHP1,204,269.80).
