**WHEREAS**, in an endorsement letter dated May 20, 2019 from the Acting City Mayor, Honorable Ramon D. Torres, addressed to this body, concerning the request of Dr. Ferdinand Ramon M. Mayoga, City Health Officer, this City, for the adoption of Presidential Decree 856, otherwise known as the Code of Sanitation of the Philippines;
