RESOLUTION NO. 19-159

RESOLUTION ADOPTING REPUBLIC ACT 8504, OTHERWISE KNOWN AS THE PHILIPPINE AIDS PREVENTION AND CONTROL ACT OF 1998.

WHEREAS, in an endorsement letter dated May 20, 2019 from the Acting City Mayor, Honorable Ramon D. Torres, addressed to this body, concerning the request of Dr. Ferdinand Ramon M. Mayoga, City Health Officer, this City, for the adoption of Republic Act 8504, otherwise known as the Philippine AIDS Prevention and Control Act of 1998;

WHEREAS, this Republic Act was enacted to promulgate policies and prescribing measures for the prevention and control of HIV/AIDS in the City, instituting a citywide HIV/AIDS information and educational program, establishing a comprehensive HIV/AIDS monitoring system, strengthening the Local AIDS Council and for other purposes;
