RESOLUTION DENYING THE REQUEST OF THE CITY OF SILAY FOR THE RENEWAL OR EXTENSION OF THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY OF BAGO AND SILAY CITY WITH REGARDS TO THE DISPOSAL OF RESIDUAL WASTES AT BAGO CITY SANITARY LANDFILL AND ECO-CENTER.

WHEREAS, Hon. Mark Andrew Arthur J. Golez of Silay City is requesting for the renewal or extension of the Memorandum of Agreement (MOA) between the City of Bago and Silay City relative to the use of the City's Sanitary Landfill for the disposal of residual waste as embodied in an agreement dated August 20, 2018 which will expire on June 30, 2019; and

WHEREAS, in a Committee Hearing conducted by the Committee on Environmental Protection of the Sangguniang Panlungsod, they recommended to the plenary to deny the request of the City of Silay, premised on the current status of the Sanitary Landfill which is almost filled up, making it impossible for the City to accommodate the residual wastes coming from other Local Government Units;
