RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) AND THE CITY GOVERNMENT OF BAGO FOR THE LAUNCHING AND IMPLEMENTATION OF GSIS FINANCIAL ASSISTANCE LOAN (GFAL) II PROGRAM.
