RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR SIGN IN THE AMENDED CONTRACT OF SERVICES ENTERED INTO BY THE CITY GOVERNMENT OF BAGO AND DR. NIÑA MARIE Y. SEDAYON EFFECTIVE JULY 1, 2019 SPECIFICALLY WITH THE FOLLOWING CHANGES:

1. SHALL RENDER SERVICES AT BAGO CITY HOSPITAL PREFERABLY ON THE FOLLOWING SCHEDULE:
MONDAYS - 10:00PM – 6:00AM
AND
SATURDAYS - 10:00PM – 6:00AM

FRIDAYS - 10:00PM – 6:00AM
2. THAT THE FIRST PARTY SHALL PAY THE SECOND PARTY TWENTY FIVE THOUSAND PESOS ONLY (P25,000.00) PER MONTH PAYABLE EVERY 15TH AND 30TH/31ST DAY OF EVERY MONTH

CHANGE TO:

2. THAT THE FIRST PARTY SHALL PAY THE SECOND PARTY FIFTY THOUSAND PESOS ONLY (P50,000.00) PER MONTH PAYABLE EVERY 15TH AND 30TH/31ST DAY OF EVERY MONTH
