RESOLUTION ADOPTING R.A. NO. 11036 ENTITLED: "AN ACT ESTABLISHING A NATIONAL MENTAL HEALTH POLICY FOR THE PURPOSE OF ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS UTILIZING PSYCHIATRIC, NEUROLOGIC AND PSYCHOSOCIAL HEALTH SERVICES, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES", OTHERWISE KNOWN AS THE MENTAL HEALTH ACT".

WHEREAS, Indorsement letter dated August 1 2018 from the Honorable City Mayor, respectfully referred to this Honorable body, the request of Mrs. Bernadette M. Somcio, LCPC Focal Person, this City, for the passage of a Resolution adopting R.A. No. 11036 entitled: "AN ACT ESTABLISHING A NATIONAL MENTAL HEALTH POLICY FOR THE PURPOSE OF ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS UTILIZING PSYCHIATRIC, NEUROLOGIC AND PSYCHOSOCIAL HEALTH SERVICES, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES", otherwise known as The Mental Health Act;
