WHEREAS, in a Committee Hearing conducted by the Committee on Environmental Protection, they recommended to the plenary to support the subject resolution based on reasons adduced by the barangay and the fact that 33 liters per second volume of water to be extracted is so huge to immensely deplete the supply of water for domestic, agricultural and other uses of the community;

WHEREAS, after thorough deliberation, this August body is of the consensus to adopt the recommendation of the Committee on Environmental Protection.


