**RESOLUTION APPROVING AND ADOPTING THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO) AND THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC), ALL OF BAGO CITY.**

**WHEREAS**, Republic Act 9344 or the Juvenile Justice and Welfare Act of 2006, is an expression of the Philippine's commitment as state party to the Convention on the Rights of the Child (CRC);

**WHEREAS**, the same Act created the Juvenile Justice and Welfare Council tasked to develop the Comprehensive Justice Intervention Program (CJJIP) which concretizes the intention of the law as well as translates its provisions and principles into action;

**WHEREAS**, Local Government Units are required to formulate CJJIP as it deemed important in order for the committee to have a clear framework as guide in coming up with plans that would respond to the needs of the children;

**NOW, THEREFORE**, upon motion of SP Member Marina Javellana-Yao, unanimously seconded by SP Members present, the Sanggunian

**RESOLVES**, as it is hereby resolved, to approve and adopt the Comprehensive Local Juvenile Intervention Program of the City Social Welfare and Development Office (CSWDO) and the Local Council for the Protection of Children (LCPC), all of Bago City.
