RESOLUTION DENYING THE REQUEST FOR FAVORABLE ENDORSEMENT OF THE QUARRY PROJECT OF MS. RICA MARIE CORNEL LOCATED AT BARANGAY NAPOLES, BAGO CITY.

WHEREAS, a request for endorsement of a quarry project by Ms. Rica Marie Cornel situated at Barangay Napoles, Bago City was referred to this level by the Office of the City Mayor with a recommendation that a Committee hearing and subsequent reassessment of available volume be conducted by PEMO and other regulating Office of the government;


WHEREAS, in an assessment by PEMO with DENR and LGU personnel, they recommended in effect that the application should not be endorsed considering the current state of the proposed site and the violations noted during the inspection;

WHEREAS, the Committee on Environmental Protection, after the conduct of series of hearings, concluded that violations were committed by the previous operator who is allegedly the husband of the current applicant and the unilateral intention of the applicant to abandon their request declaring that they will no longer pursue their application, recommended that the request for favorable endorsement will not be favorably granted, which, after thorough deliberation, is adopted by this august body.


