WHEREAS, presented in session assembled is the request for the holding of cockfighting activities at Purok Kapayyas and Purok Suha, all of Barangay Napoles, this city;

WHEREAS, peace and order must be maintained during said activity by the organizer in coordination with the Bago City Police Station;

WHEREAS, existing laws and regulations require that cockfighting activities relative to the celebration of purok, barangay and city local fiesta must be conducted in a duly licensed/designated cockpit of the local government;


