RESOLUTION ADOPTING REPUBLIC ACT 9593 ENTITLED: "AN ACT DECLARING A NATIONAL POLICY FOR TOURISM AS AN ENGINE FOR INVESTMENT, EMPLOYMENT, GROWTH AND NATIONAL DEVELOPMENT AND STRENGTHENING THE DEPARTMENT OF TOURISM AND ITS ATTACHED AGENCIES TO EFFECTIVELY AND EFFICIENTLY IMPLEMENT THAT POLICY AND APPROPRIATING FUNDS THEREFOR" OTHREWISE KNOWN AS THE TOURISM ACT OF 2009.

WHEREAS, Indorsement letter dated August 8 2018 from the Honorable City Mayor, respectfully referred to this Honorable body, the request of Mrs. Rosseni G. Mina, STOO, this City, for the passage of a Resolution adopting R.A.
