RESOLUTION ADOPTING REPUBLIC ACT 10066 ENTITLED: "AN ACT PROVIDING FOR THE PROTECTION AND CONSERVATION OF THE NATIONAL CULTURAL HERITAGE, STRENGTHENING THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) AND ITS AFFILIATED CULTURAL AGENCIES, AND FOR OTHER PURPOSES", OTHERWISE KNOWN AS THE NATIONAL CULTURAL HERITAGE ACT OF 2009.

WHEREAS, Indorsement letter dated August 8 2018 from the Honorable City Mayor, respectfully referred to this Honorable body, the request of Mrs. Rosseni G. Mina, STOO, this City, for the passage of a Resolution adopting R.A.
