RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2019-003 OF BARANGAY ALIANZA, BAGO CITY, ENTITLED: "AN ORDINANCE CREATING AND INSTITUTIONALIZING THE ESTABLISHMENT OF BARANGAY VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (VAWC) OFFICE/DESK IN BARANGAY ALIANZA, THIS CITY, PROVIDING FUNDS FOR ITS OPERATIONALIZATION AND MAINTENANCE AND THE PROTOCOL IN HANDLING VAWC CASES AT THE BARANGAY LEVEL".
