RESOLUTION EXPRESSING FAVORABLE SUPPORT FOR THE CREATION OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE OF BAGO CITY.

WHEREAS, City Disaster Risk Reduction and Management Council Resolution No. 2019-13 endorsed to this level the request for the passage of an ordinance creating the City Disaster Risk Reduction and Management Office in Bago City;

WHEREAS, this August body had referred the matter to the Committee on Disaster Risk Reduction and Management for study to which the latter come up with a recommendation stating that coming up with an ordinance creating Local Disaster Risk Reduction and Management Office with its core functions is pre-mature considering the pendency of the proposed bill in Congress creating the Department of Disaster Resilience to which the legal basis for creation and staffing pattern of the office at the local level maybe based from;

WHEREAS, it is the recommendation of the Committee on Disaster Risk Reduction and Management that in lieu of an ordinance a resolution maybe passed expressing favorable support for the creation of the Local Disaster Risk Reduction and Management Office; and

WHEREAS, it is the consensus of this August body to adopt the recommendation of the Committee on Disaster Risk Reduction and Management relative to the matter;
