#### **ORDINANCE NO. 21-16**

AN ORDINANCE AMENDING ARTICLE II, SECTION 1, LETTER A OF CITY ORDINANCE NO. 17-12, SERIES OF 2017 OTHERWISE KNOWN AS THE 2017 COMPREHENSIVE TRICYCLE OPERATIONS CODE OF BAGO CITY.

**WHEREAS,** in a committee meeting held by the Committee on Transportation and Energy a petition was taken up relative to the inclusion of certain type of tricycle which may be used by tricycle operators operating within the City;

**WHEREAS**, this type of tricycle known as L5 THREE WHEELERS has passed the quality test of the Department of Trade and Industry (DTI) and the legal requirements for registration of the Land Transportation Office (LTO) and thus, may be used in public utility transportation system industry of a given locality;

**WHEREAS**, during the committee meetings undertaken by the Committee on Transportation and Energy it was reveal that the physical features and description <u>L5 THREE</u> <u>WHEELERS</u> is not included in the definition of tricycle under Ordinance No. 17-12 necessitating an amendment of its pertinent portions.

**NOW THEREFORE,** on motion of SP Member Sergio T. Piansay and unanimously seconded by SP Members present, be it ordained by the Sanggunian Panlungsod of Bago City in a session assembled that:

**SECTION 1. AMENDATORY CLAUSE.** – Article II, Section 1, letter A is hereby amended to read as follows:

### "ARTICLE II – DEFINITION OF TERMS/ACRONYMS

Section 1.- For the purpose of this Ordinance, the following terms, words and abbreviations shall be understood and construed as follows:

A. Tricycle for Hire – is a motor vehicle composed of a motorcycle fitted with single wheel side car or a motorcycle with two-wheel cab or an L5 Three Wheelers operated to render transportation to the general public for a fee."

**SECTION 3. SEPARABILITY CLAUSE.** - If any part or portion of this Ordinance be declared unconstitutional or invalid, the unaffected portion/s hereof shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** - This Ordinance shall take effect upon approval and prescribed posting and publication.
