**ORDINANCE NO. 21-18**

**AN ORDINANCE AMENDING LETTER d, PARAGRAPH a OF SECTION 6F.03, ARTICLE F, CHAPTER V OF ORDINANCE NO. 17-10 OTHERWISE KNOWN AS THE 2017 REVISED REVENUE CODE OF THE CITY OF BAGO, AS AMENDED AND FOR OTHER PURPOSES.**

**Explanatory Note:**

**WHEREAS**, Section 6F.03, Article F, Chapter V of Ordinance No. 17-10 or the Revised Revenue Code of the City of Bago was amended by Ordinance No. 18-14;

**WHEREAS**, in the committee hearing of the committees of health and ways and means last August 3, 2021, and August 10, 2021, the matter of the inclusion of medical oxygen as a benefit for outpatient city employees was taken up and it was the consensus of both committees that the same be included in the package;

**WHEREAS**, after a thorough deliberation on the matter, the August Body is of the consensus to include medical oxygen in the package of benefits accorded to city employees by the Bago City Hospital;

**NOW, THEREFORE**, upon motion of Sangguniang Panlungsod Member Cleo F. Gaudite, unanimously seconded by all members present, be it enacted by the Sanggunian Panlungsod that:

**SECTION 1. AMENDATORY CLAUSE.** – Letter d, Paragraph a of Section 6F.03, Article F, Chapter V of Ordinance No. 17-10 or the Revised Revenue Code of the City of Bago, as amended, is accordingly amended to read as follows:

***“Section 6F.03 Administrative Provision.***

***a) xxx;***

***b) xxx;***

***c) xxx;***

***d) Officials and Employees of the City Government of Bago, after deducting the discount for senior citizen, PWD benefits, and Philhealth coverage, shall be exempted from payment of all fees and charges herein provided up to Php10,000.00 per year except for medicines and other laboratory and radiology services not available at the hospital or in health facility having an agreement with the City, subject to the following conditions that:***

***a. He/she is confined at Bago City Hospital, however, laboratory and radiology services fees and medical oxygen use may be included for outpatient.***

***b. xxx;***

***c. xxx;***

***d. xxx;”***

**SECTION 2. SEPARABILITY CLAUSE.** - If any part or portion of this Ordinance is declared unconstitutional or invalid, the unaffected portion/s hereof shall remain in full force and effect.

**SECTION 3. REPEALING CLAUSE.** - All issuances, ordinances, rules, and regulations or parts thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. EFFECTIVITY.** - This Ordinance shall take effect immediately upon its approval.
