RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE 24 BARANGAYS OF THE CITY FOR THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS ONLY (PHP30,000.00) IN CONNECTION WITH THE 55TH CHARTER ANNIVERSARY OF THE CITY.

WHEREAS, letter dated January 19, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing him to sign for and in behalf of the City of Bago in the Project Proposal and Memorandum of Agreement to be executed by and between the City Government of Bago and the 24 Barangays of the City for the grant of financial assistance in the amount of Thirty Thousand Pesos Only (Php30,000.00) in connection with the 55th Charter Anniversary of the City;
