RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF HEALTH, CITY GOVERNMENT OF BAGO, BAGO CITY HOSPITAL, DR. JOSE GIANNI C. ESPADA AND SOUTHERN PHILIPPINES MEDICAL CENTER TO RENDER POST-RESIDENCY DEPLOYMENT SERVICE IN BAGO CITY HOSPITAL AS PART OF THE REQUIREMENTS OF THE RESIDENCY TRAINING PROGRAM PURSUANT TO ADMINISTRATIVE ORDER NO. 2015-0021.
