**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE PROVINCE OF NEGROS OCCIDENTAL, CITY GOVERNMENT OF BAGO AND 24 BARANGAYS OF BAGO CITY, NEGROS OCCIDENTAL BY PROVIDING AN INSURANCE INCENTIVE PLAN TO BARANGAY OFFICIALS AND WORKERS DURING THEIR TENURE OF SERVICE BY WAY OF A GROUP INSURANCE PROGRAM.**

**WHEREAS**, letter dated January 26, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing him to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and among the Province of Negros Occidental, City Government of Bago and 24 Barangays of Bago City, Negros Occidental by providing an insurance incentive plan to barangay officials and workers during their tenure of service by way of a Group Insurance Program;
