GELEEN ANNE T. PROCIANOS AND CORAZON LOCSIN MONTELIBANO MEMORIAL REGIONAL HOSPITAL FOR PROVIDING HEALTHCARE SERVICES THROUGH POST-RESIDENCY DEPLOYMENT PROGRAM OF THE DEPARTMENT OF HEALTH (DOH).
