RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE CITY GOVERNMENT OF BAGO FOR THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND (SLRF) UNDER R.A. 8794.
