**RESOLUTION NO. 21-079**

**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN IN THE DEED OF DONATION AND ACCEPTANCE FOR THE TURNOVER OF COMPLETED DEVELOPMENT WORKS.**

**WHEREAS**, in a letter dated February 23, 2021, the Honorable City Mayor Nicholas M. Yulo sought legislative action to support the City Government's intention of availing the Resettlement Assistance Program for Local Government Unit (RAP-LGU);

**WHEREAS**, the Resettlement Assistance Program for Local Government Unit (RAP-LGU) of the National Housing Authority extends technical and financial assistance for LGUs in the development of Resettlement Sites, to a maximum of P50 Million pesos, under a half grant-half loan scheme payable for 14 years without interest;

**WHEREAS**, as a requisite for the availment of said RAP-LGU, a resolution authorizing the Honorable City Mayor to sign in the Deed of Donation and Acceptance of turnover of completed development works should be passed by this August body; and

**WHEREAS**, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;

**NOW, THEREFORE**, upon motion of SP Member Cleo F. Gaudite, unanimously seconded by SP Members present, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to authorize the Honorable City Mayor to sign in the Deed of Donation and Acceptance for the turnover of completed development works.
