RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DISCALCED CARMELITE FATHERS, INC., FOR THE EXTENSION OF LEASE AS COMMUNITY ISOLATION UNIT FOR PROBABLE AND SUSPECTED COVID-19 CASES IN THE CITY OF BAGO.

WHEREAS, letter dated March 10, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Discalced Carmelite Fathers, Inc., for the extension of lease as Community Isolation Unit for probable and suspected COVID-19 cases in the City of Bago;
