RESOLUTION NO. 21-099

RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE CONVERSION OF BAGO MAMBUCAL ROAD (S00166NR)-BARANGAY CARIDAD-BARANGAY SAGASA-BARANGAY AYUNGON-BARANGAY SIBUCAO-JUNCTION BAGONAWA-LA CASTELLANA ROAD (S00175 NR) WITH A TOTAL LENGTH OF 3.687 KILOMETERS FROM LOCAL ROAD INTO A NATIONAL ROAD.

WHEREAS, letter dated March 10, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago as "Conforme" in the certification issued by the District Engineer of the Department of Public Works and Highways (DPWH), 4th District Engineering Office in connection with the conversion of local road into a National Road that covers part of Bago City land area with a total length of 3.687 kilometers;

WHEREAS, this matter was referred to the Committee on Engineering and Public Works and upon review of DPWH Department Order No. 133, Series of 2018, what is required from the local government is a resolution regarding the conversion of a specific local road into a national road;

WHEREAS, after thorough deliberation, it is the consensus of the August body to favorably enact the required resolution premised on the fact that DPWH shall take care of the road right of way issues;

NOW, THEREFORE, upon motion of SP Member Ma. Femmy A. Martir, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to request the Department of Public Works and Highways (DPWH) for the conversion of Bago Mambucal Road (S00166NR)-Barangay Caridad-Barangay Sagasa-Barangay Ayungon-Barangay SibUCAO-Junction. Bagonawa-La Castellana Road (S00175 NR) with a total length of 3.687 kilometers from local road into a national road.
