**RESOLUTION NO. 21-132**

**RESOLUTION AMENDING THE RULES OF PROCEDURE OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BAGO PARTICULARLY SECTION 1, RULE II, SESSIONS AND QUORUM.**

**WHEREAS**, this body is of the consensus to amend Section 1, Rule II, Sessions and Quorum to read as follows:

**RULE II**  
Sessions and Quorum

Sec. 1 – Session defined – A session is a meeting which, although lasting for several hours, is one meeting. The Sangguniang Panlungsod shall hold one ordinary session each week for transacting business and also such number of special sessions as may be called in accordance with law. In extraordinary cases such as in times of pandemic and other emergencies which endangers the health, well-being and safety of the members and staff, sessions may be conducted virtually via available internet platforms or apps duly approved by the Body.;

**WHEREAS**, the Committee on Laws, Rules and Procedures aims to amend the above-mentioned Section 1, Rule II, Sessions and Quorum, in order to adapt with the “new normal” situation brought about by the COVID-19 pandemic, so as not to disrupt the local legislation functions of the Sangguniang Panlungsod;

**NOW, THEREFORE**, upon motion of SP Member Jorge Agustin A. Araneta, unanimously seconded by SP Members present, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to amend the Rules of Procedures of the Sangguniang Panlungsod of the City of Bago particularly Section 1, Rule II, Sessions and Quorum.
