RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF HEALTH-WESTERN VISAYAS FOR HEALTH DEVELOPMENT, BAGO CITY HOSPITAL AND THE CITY GOVERNMENT OF BAGO IN REGARDS TO THE ALLOCATION OF FIFTY THOUSAND PESOS (PHP50,000.00) FROM DOH-CENTRAL OFFICE ALLOCATED FOR BAGO CITY HOSPITAL AS MEDICAL ASSISTANCE TO INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS UNDER THE CY 2021 CURRENT FUNDS OF THE MEDICAL ASSISTANCE TO INDIGENT PATIENTS (MAIP) PROGRAM OF THE DOH.

WHEREAS, letter dated May 18, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the Department of Health-Western Visayas for Health Development, Bago City Hospital and the City Government of Bago in regards to the allocation of Fifty Thousand Pesos (Php50,000.00) from DOH-Central Office allocated for Bago City Hospital as medical assistance to indigent and financially incapacitated patients under the CY 2021 current funds of the Medical Assistance to Indigent Patients (MAIP) Program of the DOH;
