**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN AN AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE CITY GOVERNMENT OF CADIZ ON THE ESTABLISHMENT OF LINKAGE AND NETWORK FOR DISASTER RISK REDUCTION AND EMERGENCY RESPONSE.**

**WHEREAS**, letter dated July 13, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in an Agreement to be executed by and between the City Government of Bago and the City Government of Cadiz on the establishment of linkage and network for Disaster Risk Reduction and Emergency Response;
