RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CARESPAN ASIA, INC., FOR THE FREE USE OF CARESPAN DIGITAL HEALTH PLATFORM (FOR VIRTUAL MEDICAL CONSULTATION) FOR A PERIOD OF ONE (1) YEAR.

WHEREAS, letter dated July 6, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and CARESPAN ASIA, INC., for the free use of Carespan Digital Health Platform (for virtual medical consultation) for a period of one (1) year;

WHEREAS, the matter was referred to the Committee on Ways and Means which recommended favorably the grant of said request, and the Plenary, after a thorough deliberation on the matter, is of the consensus to adopt the recommendation;
