RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE DATA PROCESSING AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CARESPAN ASIA, INC., FOR THE PROCESSING OF DATA OF PATIENTS IN COMPLIANCE WITH R.A. 10173 OR THE DATA PRIVACY ACT OF THE PHILIPPINES AND R.A. 11332 OR THE MANDATORY REPORTING OF NOTIFIABLE DISEASES AND HEALTH EVENT OF PUBLIC CONCERN ACT.

WHEREAS, letter dated July 6, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Data Processing Agreement to be executed by and between the City Government of Bago and CARESPAN ASIA, INC., for the processing of data of patients in compliance with R.A. 10173 or the Data privacy Act of the Philippines and R.A. 11332 or the mandatory Reporting of Notifiable Diseases and Health Event of Public Concern Act;

WHEREAS, the matter was referred to the Committee on Ways and Means which recommended favorably the grant of said request, and the Plenary, after a thorough deliberation on the matter, is of the consensus to adopt the recommendation;
