**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND LANDBANK OF THE PHILIPPINES (LBP) IN PROVIDING AN ELECTRONIC BANKING SERVICES TO ALLOW PARTNER-MERCHANTS' CLIENTS TO DIRECTLY TRANSACT WITH THE LANDBANK.**
