RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE ON BEHALF OF THE CITY OF BAGO CONCERNING THE OFFER TO SELL OF REAL PROPERTY BY FR. GREGORIO PATIÑO AND FR. ROMEO E. EMPESTAN, SITUATED IN BARANGAY NAPOLES, BAGO CITY, UNDER LOT TITLE NO. T-21740 CONTAINING AN AREA OF SEVENTY-TWO THOUSAND FOUR HUNDRED EIGHTY-FIVE (72,485 SQ. M.) FROM THE INITIAL SELLING PRICE OF ₱150.00/SQ.M. TO ₱130.00/SQ.M.
