RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE DEED OF ABSOLUTE SALE TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, FR. GREGORIO PATIÑO AND FR. ROMEO E. EMPESTAN, FOR THE PURCHASE OF LOT UNDER LOT NO. 408-D-3, COVERED BY CERTIFICATE OF TITLE NO. T-21740 CONTAINING AN AREA OF SEVENTY-TWO THOUSAND FOUR HUNDRED EIGHTY-FIVE (72,485 SQ.M.) MORE OR LESS SITUATED IN BARANGAY NAPOLES, BAGO CITY.

WHEREAS, letter dated August 31, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Deed of Absolute Sale to be executed by and among the City Government of Bago, Fr.
