RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR A PARTNERSHIP IN A SCHOLARSHIP PROGRAM OF THE PROVINCIAL GOVERNMENT.

WHEREAS, letter dated August 31, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Provincial Government of Negros Occidental and the City Government of Bago for a partnership in a Scholarship Program of the Provincial Government;
