RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE OVERSEAS WORKERS WELFARE ADMINISTRATION REGIONAL WELFARE (OWWA) OFFICE VI AND THE CITY GOVERNMENT OF BAGO FOR THE ESTABLISHMENT OF OFW MIGRANT HELP DESK IN THE CITY.

WHEREAS, letter dated September 7, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Overseas Workers Welfare Administration Regional Welfare (OWWA) Office VI and the City Government of Bago for the establishment of OFW Migrant Help Desk in the City;
