RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF EDUCATION-DIVISION OF BAGO CITY FOR THE USE OF THE CITY-OWNED RADIO STATION FOR THE MODULAR/BLENDED LEARNING OF THE STUDENTS OF THE CITY OF BAGO.

WHEREAS, letter dated September 21, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Department of Education-Division of Bago City for the use of the City-owned radio station for the modular/blended learning of the students of the City of Bago;
