WHEREAS, letter dated September 21, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the National Housing Authority and the City Government of Bago for the development of Taloc Village located at Barangay Taloc, Bago City;
