PALMA AS VILLAGE-BASED AI TECHNICIAN (VBAT) BY VIRTUE OF REPUBLIC ACT 7307 OTHERWISE KNOWN AS THE "PHILIPPINE CARABAO ACT OF 1992".

WHEREAS, letter dated September 28, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Joemar P.
