RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF EDUCATION DIVISION OF BAGO CITY, NORTHERN NEGROS STATE COLLEGE OF SCIENCE AND TECHNOLOGY AND THE CITY GOVERNMENT OF BAGO FOR A PARTNERSHIP KNOWN AS THE "ESTABLISHMENT OF SCHOOL HEADS ACADEMY FOR DEPED DIVISION OF BAGO CITY".
