RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGIONAL OFFICE VI AND THE CITY GOVERNMENT OF BAGO FOR THE IMPLEMENTATION OF THE FOLLOWING PROJECTS: 1.) MILKFISH FINGERLINGS DISTRIBUTION, AND 2.) PROVISION OF PROCESSING UTENSILS.

WHEREAS, letter dated September 29, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the Bureau of Fisheries and Aquatic Resources, Regional Office VI and the City Government of Bago for the implementation of the following projects: 1.)
