RESOLUTION NO. 21-285

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE DEED OF USUFRUCT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) AND THE CITY GOVERNMENT OF BAGO GRANTING A USUFRUCTUARY RIGHTS TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES OFFICE BAGO CITY OVER A PORTION OF FIVE THOUSAND SIX HUNDRED EIGHTY-SIX SQUARE METERS (5,686 SQ.M.) OF A PARCEL OF LAND OWNED BY THE CITY OF BAGO, NEGROS OCCIDENTAL LOCATED AT LOT 1, BANTAYAN PARK, BARANGAY POBLACION, BAGO CITY.

WHEREAS, letter dated October 19, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Deed of Usufruct to be executed by and between the Department of Environment and Natural Resources (DENR) and the City Government of Bago granting a usufructuary rights to the Department of Environment and Natural Resources Office Bago City over a portion of Five Thousand Six Hundred Eighty-Six Square Meters (5,686 sq.m.) of a parcel of land owned by the City of Bago, Negros Occidental located at Lot 1, Bantayan Park, Barangay Poblacion, Bago City;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;
