RESOLUTION AUTHORIZING THE CITY TREASURER TO TRANSFER FUNDS FROM THE GENERAL FUND TO TRUST FUND AMOUNTING TO SEVEN HUNDRED EIGHTY-EIGHT THOUSAND EIGHT HUNDRED THIRTY-NINE PESOS (₱788,839.00) FOR THE PAYMENT OF THE MUNICIPAL DEVELOPMENT FUND OFFICE (MDFO) LOAN OF THE CITY FOR THE CONSTRUCTION AND IMPROVEMENT OF STREETLIGHTS ALONG RAFAEL SALAS DRIVE, BARANGAY BALINGASAG, BAGO CITY.

WHEREAS, letter dated November 10, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a Resolution authorizing the City Treasurer to transfer funds from the General Fund to Trust Fund amounting to Seven Hundred Eighty-Eight Thousand Eight Hundred Thirty-Nine Pesos (₱788,839.00) for the payment of the Municipal Development Fund Office (MDFO) Loan of the City for the Construction and Improvement of Streetlights along Rafael Salas Drive, Barangay Balingasag, Bago City;
