**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY OF BAGO AND DEPARTMENT OF HEALTH-WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT, FOR A GRANT TO THE CITY TO AN AMOUNT OF ₱250,000.00/₱400,000.00 FROM ITS UNIVERSAL HEALTH CARE (UHC) GRANT FUNDS.**

**WHEREAS**, letter dated November 23, 2021 from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City of Bago and Department of Health-Western Visayas Center for Health Development wherein the latter shall give a grant to the City to an amount of ₱250,000.00/₱400,000.00 from its Universal Health Care (UHC) Grant Funds;
