RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT AND DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE CITY OF BAGO AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB) WHEREIN THE LATTER SHALL DONATE TO THE CITY ONE (1) UNIT BIODEGRADABLE WASTE SHREDDER AND ONE (1) UNIT OF COMPOSTER IN THE IMPLEMENTATION OF REPUBLIC ACT 9003.

**WHEREAS**, letter dated December 1, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement and Deed of Donation to be executed by and between the City of Bago and the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB) wherein the latter shall donate to the City One (1) unit Biodegradable Waste Shredder and One (1) unit of Composter in the implementation of Republic Act 9003;
