RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR A FINANCIAL ASSISTANCE IN THE ESTABLISHMENT OF BOARDWALK IN THE MANGROVE-ECO PARKS OF COASTAL WETLAND AREA IN BARANGAYS SAMPINIT AND POBLACION, ALL OF BAGO CITY.

WHEREAS, letter dated December 27, 2021, from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in the Project Proposal and Memorandum of Agreement to be executed by and between the Provincial Government of Negros Occidental and the City Government of Bago for a financial assistance in the establishment of boardwalk in the Mangrove-Eco Parks of Coastal Wetland area in Barangays Sampinit and Poblacion, all of Bago City;
